 - ▶ The most secure system, is a well understood one!

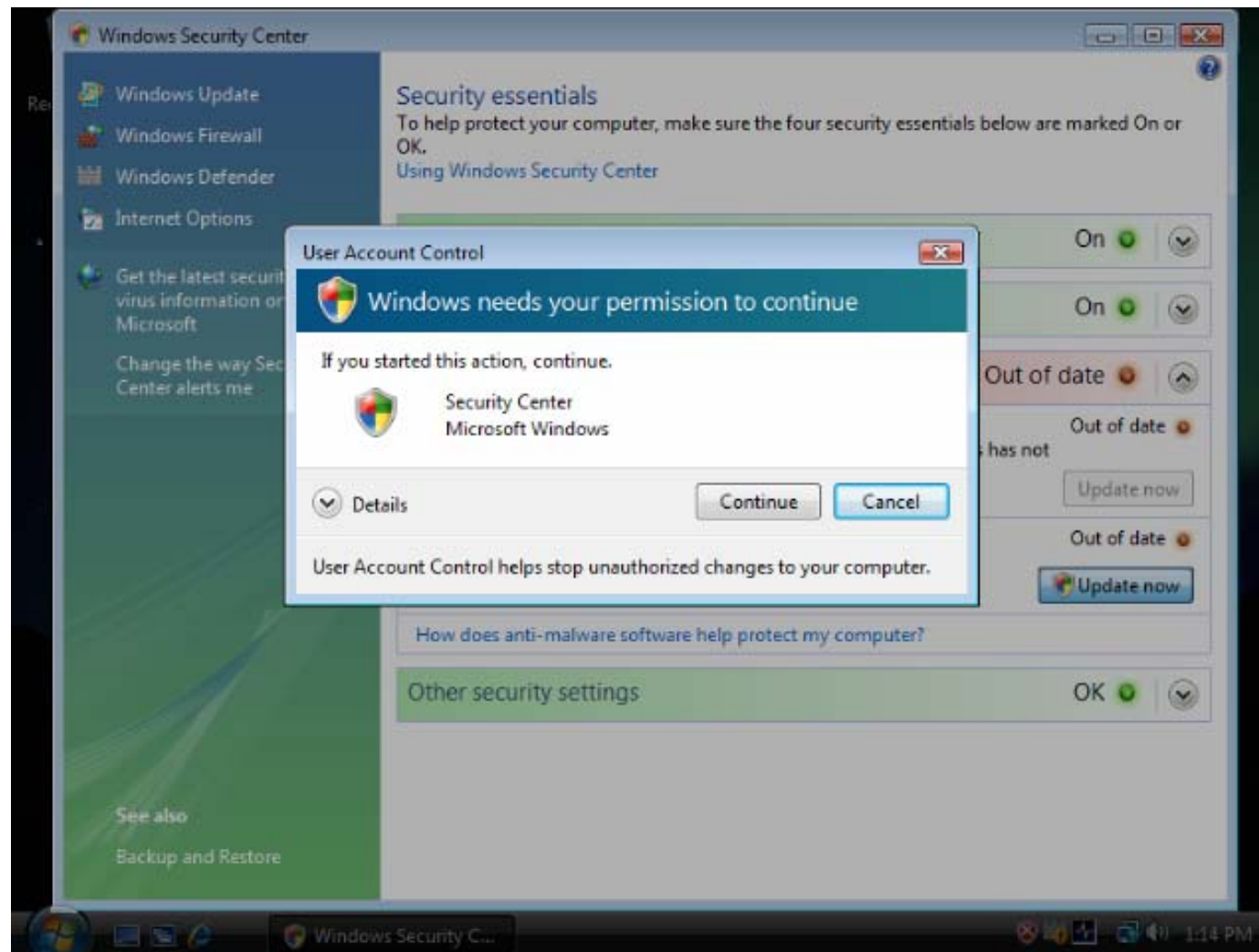

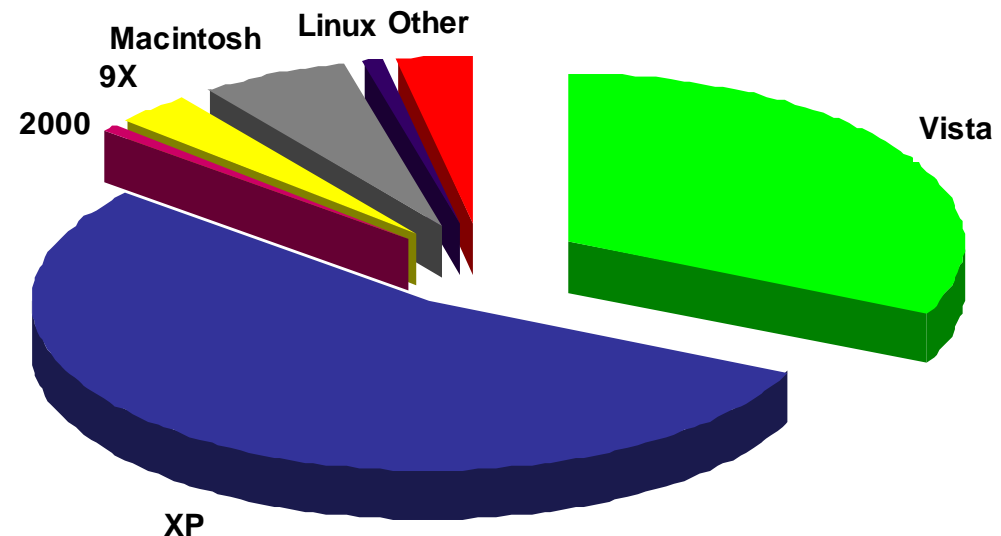

- Other – 3%

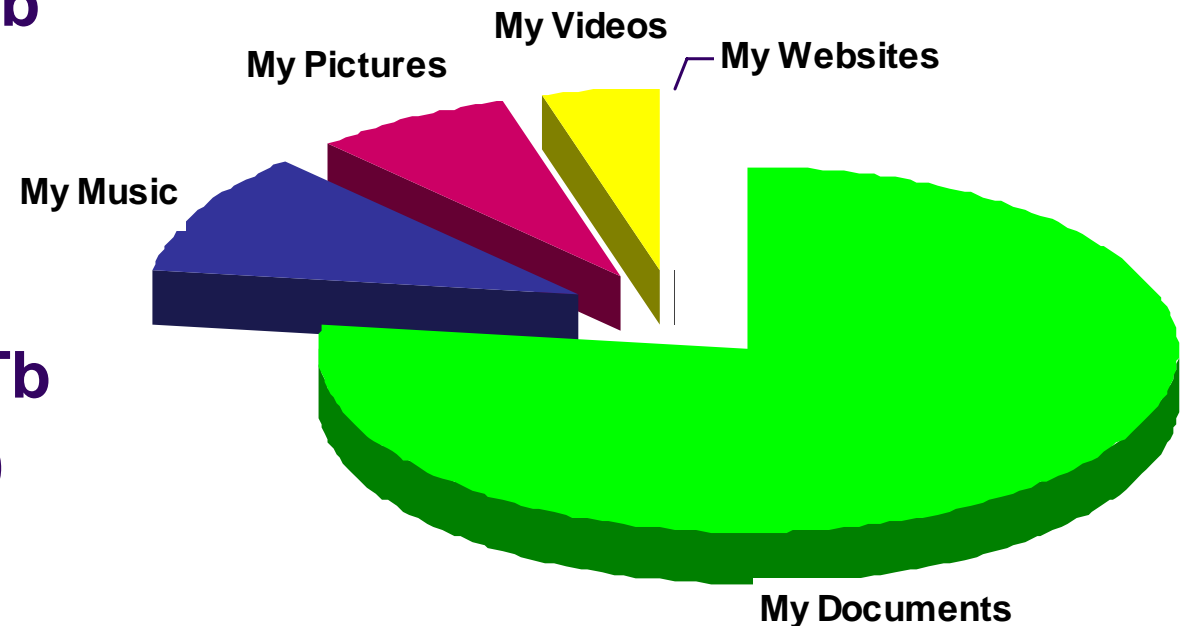


► Breakdown of 'My Documents'

▶ Known Issues

Security and Compliance Team

- ▶ Disabled virtualisation breaks applications
- ▶ UAC required for IE Protected Mode
- ▶ Sound abstraction
- ▶ Bitlocker limitations
- ▶ Sysprep problems (Three times failing/Naming)
- ▶ Image X problems (Fast mode support)
- ▶ VSS problems with applications and stubs

▶ Security Considerations

Security and Compliance Team

- ▶ Microsoft Vista can provide increased security
- ▶ Improved firewall
- ▶ Defender
- ▶ Application abstraction
- ▶ Increased network posture
- ▶ IPv6 Considerations
- ▶ Increased number of services
- ▶ Weak point is always the user

- ▶ Many sites holding back
 - ▶ Await the release of Service Pack 1 (Q1 2008)
- ▶ Continuous evaluation, ahead of pilot
- ▶ Compatibility Issues
- ▶ Summer 2008 staged roll out
- ▶ One component of “Business and IT Strategy”
 - ▶ Virtualisation
 - ▶ DR/BC
 - ▶ SAN Technology
 - ▶ Environmental Agenda
